FIRST AMENDMENT TO LEASE AGREEMENT

THIS FIRST AMENDMENT TO LEASE, executed at Seattle, Washington on February ______, 1997, by and between Mrs.

Florence Walker, hereinafter referred to as Florence, and Friends of the Walker Rock Garden, a Washington nonprofit corporation, hereinafter referred to as Tenant, upon the following terms and conditions agrees follows:

RECITAL

Florence and Tenant executed a certain Lease Agreement on February 7, 1994, for the Tenant to utilize 5407 37th Ave. S.W., Seattle Washington, more particularly described as Lot Eleven (11) Block (2), Wilbur's Addition to the City of Seattle according to recorded plat thereof. The parties to the Lease Agreement have agreed to amend the Lease Agreement as follows:

- 1. The parties acknowledge that Tenant is current in all lease obligations and is not in default of the lease.
- 2. The rock garden suffered structural damage since the inception of the lease. The parties agree that any capital improvements made to the property by the Tenant to preserve the rock garden may be applicable to the down payment that Tenant make should it exercise its option to purchase the property under paragraph 17 of the lease. Tenant shall keep records of all monies expended to preserve the garden and those records will be the basis on which the parties set the amount of credit Tenant receives toward the downpayment. Florence shall have no duty to repay any amounts expended and if the Tenant does not exercise its option, all imprevements shall inure to Florence. Florence agrees to hold harmless any further damage caused by the repairs attempted by Tenant unless the damage is caused by Tenants willful conduct.
- 3. The lease term shall be extended for one year and the termination date shall be the earlier of December 31, 2000 or sixty days after the death of Florence Walker.
- 4. Except as set forth in this First Amendment of Lease, all of the terms and conditions of the Lease shall remain unchanged and in full force and effect, however, where there is conflict between this First Amendment and the Lease the provisions of this

First Amendment shall prevail.
