Re: Demolition of Elder Anderson Johnson's house and mission in Newport News, Virginia.

March 29, 1995

I am not sure if you are familiar with Elder Anderson Johnson's work. He is an artist living and working in Newport News, Virginia who also is a preacher with a small mission that meets weekly at his home and he is also a musician. He is a kind and gentle man who has risen above a great many adversities in his life and at the age of seventy eight he is still painting daily, administering to his small flock, and playing original music. His art work has been shown in a number of exhibitions of self taught artists and several of his pieces are currently on tour in Passionate Visions of the American South organized by the New Orleans Museum of Art. This show will be at The Corcoran Gallery of Art in Washington, D.C. until May 7, 1995.

Elder Johnson's home (and mission) have been slated for demolition by the city of Newport News to make way for a recreation center. The city has bought his home from him and he has rented another and he is quite content in his new surroundings. But, those of us interested in preserving environments are particularly upset because of the exceptional wall paintings throughout the original house and the loss of another connection to our heritage and the heritage of the community.

The house is in poor condition, and although the city is willing to give away the plaster walls that are covered with the paintings, we are concerned that the paintings will not survive. To preserve the house and possibly have to move it will be costly and the city is not ready to undertake the project.

A small group of citizens met with the City Planner in the fall of '94, and since then Deborah McLeod, curator of the Peninsular Fine Arts Center in Newport News, has done a wonderful job. She has organized and met with a neighborhood committee (active now) and has met with the City Council three times. She has also approached several foundations about the possibility of funding and has received positive, though certainly tentative responses from three of them. We are now in need of support from throughout the country to try and get at least a partial commitment from the city to help. They have received a number of letters and printed material about Elder Anderson Johnson, but these have all been from a relatively small geographic area.
