SCOPE AND CONTENT NOTE

The Valley of the Moon Collection consists of two boxes and one guest register (approximately 1 cubic foot) containing archival material arranged in two record groups: The Valley of the Moon, and The Valley of the Moon Restoration Association/ George Phar Legler Memorial Society.

The Collection relates to the construction, operation and use of the Valley of the Moon amusement park, from the 1920's to the mid-1980's. The park is a unique part of Tucson's local history. Its tours and shows exemplify a period in America's entertainment history that has now passed. The Collection is also valuable for its biographical insights on park creator George Legler. ;

Record Group I

Record Group I, The Valley of the Moon, consists of seven series: (1) Business Correspondence, Incoming and Outgoing, 1942-1956; (2) Manuscripts; (3) Legal Documents, 1935, 1951; (4) Maps, 1953; (5) Printed Material, 1938-1953; (6) Miscellaneous Material, Valley of the Moon Restoration Association, 1973-1982; (7) Register/Scrapbook.

The correspondence, in Series One, includes a letter from Governor Howard Pyle and correspondence with the Arizona Fish and Game Commission regarding a permit to keep wild animals. There are also many thank-you letters from visitors to the park, and

correspondence inviting George Legler to perform his "Bunnyland" rabbit shows around the country.

Some manuscripts in the Collection were composed by George Legler and reflect his personal philosophies.

Series Four consists of a blueprint for proposed property improvements.

The Abstract of Title, in Series Three, lists owners of the Valley of the Moon property, dating from 1890, and there is an index of all names listed in the Abstract.

Various printed materials, in Series Five, include flyers and pamphlets which describe the Valley of the Moon attractions.

The guest register/scrapbook, in Series Seven, includes names of visitors from 1937 to 1955; the back of the register contains newspaper clippings pasted to the pages.

The business correspondence, in Series One, includes a letter from the Arizona State Parks, adding the Valley of the Moon to the Arizona List of Historical Places. Series Three

contains bylaws, minutes, memos, etc., that pertain to internal proceedings within the Association/Society.

The financial reports, in Series Four, include figures for membership dues and expenses for running the park.

The legal documents, in Series Five, include George Legler's will, his death certificate, and his gift deed of the Valley of the Moon property to the Association.

In Series Six, Seven, and Eight, there are several anonymous manuscripts, a blueprint of building plans, a map of the layout of the property, and many miscellaneous flyers and pamphlets.
