As the chairman of the Select Committee on Tourism and Aviation, I am requesting an inquiry on the whereabouts of State Historical Landmark #939, Possum Trot.

The matter of the landmark's disappearance was brought to my attention by Ms. Nancy Aguilar in a recent letter. It is also my understanding that Ms. Aguilar has contacted the State Historical Resources Commission, and was referred to you. Subsequently, she wrote you last February, but has not received a response. The main concern is that the Possum Trot artifacts are no longer at a State designated historical site and may be in possession of private collectors.

I would greatly appreciate an immediate response to this matter. If you have any comments or question, you may contact my representative, Juan Mejia at my district office. Thank you for your anticipated cooperation.
